FBCS scores higher on Language Arts and Science than other North Idaho schools on L.A. and Science, with the exception of North Idaho STEM Charter Academy. Mary also explained that FBCS scores are lower in Math because of the inclusion of Special Education in the overall score. There has been a dramatic increase in SpEd students, with an increase from 9% to 25% of the student population. Without SpEd students, the school scores high on Math.
